Grounds: The trial grounds are located on Hwy. 180, between Snyder and Anson, TX. The entrance to the grounds is located 39 miles west of Anson; 22 miles east of Snyder and is on the south side of the road. Signs will be posted at the trial grounds' entrance and to the camping area. There are a limited number of horse pens available. Water will be available in the camp area for dogs and horses. There is no electricity.

Lunches: Available on the grounds each day for a nominal cost.

Daily Running: Six (6) one-hour braces are scheduled each day; however in the event of an early termination of a brace, the 7th brace will be on

standby. NO cell phone use during running of braces. NO smoking is allowed on the grounds.

Entry Fees: *Championship*—\$165.00. It is a condition of acceptance for the Championship that each entry furnishes an AFTCA Win Certificate number for Derby or All-Age Placement (1st, 2nd, 3rd) for dog and handler per AFTCA Bylaws Article III, Section 8, and dogs must be entered by their registered name; *M.G. Perkins Amateur All-Age Derby Classic*—\$75.00. Entry fee expected if dog is drawn.

Owners and handlers must be members of the AFTCA. Please include your individual AFTCA membership number with your entries.

Awards: Purina dog food to all placed dogs in both stakes. Region 7 Championship plaques to champion and runner-up. Prizes to all placed dogs in the Derby.
